**PAYMENT PLAN AGREEMENT**

I agree to follow the payment plan according to the guidelines set forth by Cruisers Driving School, L.L.C. I understand that if payments are not honored by my bank or the payment plan schedule is not kept current, services will cease. Fees are non-refundable if Cruisers is willing and able to fulfill its part of the service agreement. Service Agreement prices are guaranteed for a maximum of 8 months from receipt of Instruction Permit and subject to change based on fee schedule in place upon completion date of training.

- **Missed Lesson Fee of \$50.00** will be applied to the student's account if the student fails to cancel 24 business hours in advance or does not report at the car for any reason; arrives more than 10 minutes late; failure to have account current prior to beginning of lesson; failure to have Temp License with them or failure to be in condition to drive.
- **Returned Check /Non-sufficient Funds Fee of \$50.00** will be applied to the student's account if payments by check are not honored in full by your bank upon deposit.
- **Credit Card Surcharge:** We may impose a surcharge of 2.75% on credit card transactions, which is not greater than our cost of acceptance.
- **Administrative Surcharge of \$25.00** may be applied to the student's account if they fail to call and schedule their 1<sup>st</sup> behind the wheel lesson within 60 days of receipt of their Instruction Permit. **It is the student's responsibility to call and schedule their 1<sup>st</sup> BTW lesson immediately after receipt of their Temps.**
- **Full Payment** is due on or before the end of the payment plan. If you are unable to make a scheduled payment or need an alternative agreement, please call the office. We will attempt to work out a satisfactory option. Account is due and payable in full upon default of agreed payment plan schedule if alternate arrangements are not made in advance.
