CLASSROOM TRAINING State law requires 30 hours of classroom training with mandatory attendance. To receive your certificate of completion all missed classroom time must be made up by attending the missed class number with the next session. Call the office for available make-up dates. Inappropriate behavior will not be tolerated. Following one warning, subsequent inappropriate behavior will be grounds for dismissal from the class and will require a make up class. Parents or Sponsors will be required to conference with staff prior to attending next class. The students are required to keep the classroom in a safe and clean condition. The school will close promptly 15 minutes following completion of evening classes. Cruisers Driving School is not responsible for students who are not picked up in a timely manner. A passing score of 80% or better is required on the final test. Any student failing to attain a passing grade must make arrangements with staff to be re-examined at a future scheduled class.
